Student arrested for chalking 'Black Pre-born Lives Matter' outside DC Planned Parenthood

A pro-life college student was arrested August 1st while chalking "Black Pre-Born Lives Matter" on the sidewalk outside of a Washington, D.C. Planned Parenthood clinic.

Erica Caporaletti, a 22-year-old student at Townson University in nearby Maryland, was arrested along with 29-year old D.C. resident Warner DePriest. They were arrested while writing the phrase, and charged with defacing public or private property. They were detained and cited, but reportedly returned to the scene about an hour later.

The pair were participating in a protest organized by Students for Life of America. The group claims it was originally told it could paint in the street, and was even issued a permit.

"After applying and receiving our permit and after being told by the Metropolitan police that the Mayor has 'opened a Pandora's box' by painting public streets, Students for Life arrived at the D.C. Planned Parenthood on Saturday, August 1st to six police cars threatening to arrest our team and student leaders if we painted 'BLACK PREBORN LIVES MATTER,' even using the temporary paint we bought that the Police Department specifically requested," the group recounted. "When we asked if we could at least use sidewalk chalk to chalk our anti-violence message on the streets, the police threatened to arrest us.

Satanic Temple Raffles Off Free Abortion to Promote Killing Babies as Religious Rituals

The Satanic Temple (TST) launched a campaign to promote its "religious abortion ritual," which it compares to baptism or communion for Christians.

The "ritual" celebrates the killing of an innocent unborn child by abortion. TST claims the deadly practice follows two of its tenets: bodily autonomy and adherence to best scientific practices.

On August 5, the TST announced plans to challenge state abortion laws based on the claim that they violate its members' religious liberty. To fund its pro-abortion efforts, it is raising money through a raffle. The "grand prize" for those who donate at least \$200 is an abortion.

Former satanist Zachary King said that the cult performs satanic rituals inside abortion facilities. King said participating in abortions is particularly important for satanists because it is considered the best way to give an offering to Satan. He explained: "In Satanism, killing something or the death of something is the most effective way of getting your spell accomplished. As far as trying to get Satan's approval, to give you something that you want, killing something is the best way to go. Nebraska 12th State to Ban Dismemberment Abortions

Nebraska became the twelfth state in the nation to enact a dismemberment abortion ban – but not without a tremendous fight. Planned Parenthood and the ACLU led well-funded campaigns to oppose the bill and pro-abortion senators performed a filibuster at each round of debate in an effort to kill the bill. After COVID-19 caused the legislature to recess for many weeks, there was little time to move the bill through the legislative process. But on the last day of session, the Nebraska Senate passed the bill with 33 "yes" votes, eight "no" votes and seven senators not voting. Bioethics Panel Rejects 13 Projects Using Body Parts From Aborted Babies

A new bioethics advisory board appointed by the President released its first report Tuesday, recommending that the government reject funding for 13 of 14 research projects that plan to use aborted baby body parts.

The New York Times called the board's recommendations to U.S. Department of Health and Human Services (HHS) Secretary Alex M. Azar II a "de facto government ban" on funding scientific research that uses cells from aborted babies.

The board examined 14 research grant proposals based on "the scientific justification for the use and quantity of HFT [human fetal tissue] proposed and the use of alternate models" as well as whether there was adequate informed consent for the mothers donating it, according to the report.

By a majority vote, it rejected recommending all but one of the requests for funding. Among their concerns were a study that was "too interwoven with the practice of abortion" and others that could have used tissue from miscarried babies instead.

Doctors Euthanize Hundreds of Canadians Because They're Lonely

The country's 2019 MAID [medical assistance in dying] Annual Report found that 13.7 percent of the 5,631 Canadians killed by doctors asked to be lethally injected because of "isolation or loneliness." That's about 771 people, or 64 a month, or two per day.

The country is now engaged in the process that will expand the conditions qualifying for lethal injection, including incompetent people with dementia if they asked to be put down in an advance directive.

Bayer to Pay \$1.6 Billion in Essure Contraception Injury Settlement

Approximately 39,000 women filed claims saying they were injured by the device, which is a metal coil that is inserted in a fallopian tube. The coil damages the fallopian tubes, and the scarring caused by the coil blocks the tubes entirely.

As part of the settlement, Bayer will not admit that the company was in the wrong and will not apologize to the women injured by Essure.

In some instances, women were required to have emergency hysterectomies after the devices broke and migrated throughout their bodies. Others suffered extreme allergic reactions to the metals in the device, developed headaches and mood disorders, and some even experienced ectopic pregnancies.

At least one woman was killed as a result of Essure, after her reproductive organs developed necrosis, and the device was blamed for at least 300 fetal deaths and stillbirths.

Study Confirms Abortion is a "Major Cause of Death" for Black People

Black Americans are being disproportionately killed by abortions but few are talking about it, researchers asserted in a new study in the Journal of Health Services Research and Managerial Epidemiology.

"Black women have been experiencing induced abortions at a rate nearly 4 times that of White women for at least 3 decades, and likely much longer," they wrote. "The science community has refused to engage on the subject and the popular media has essentially ignored it."

They based their study on data from the annual abortion report from the Centers for Disease Control, abortion numbers from the Guttmacher Institute and other studies on mortality, fertility and abortion.

"... the evidence is clear that for many decades Black children in the United States have not had, and do not have today, an equal opportunity to survive until birth," they concluded. <https://www.lifenews.com/2020/08/27/study-confirms-abortion-is-a-major-cause-of-death-for-black-people/>
